3. Report on November 2019 NHACSS Annual Workshop – Holly Green

Wetlands presentation, one of changes local river advisory committee and ponds have certain permits that they need to sign off on. Changes are also to streamline the process. There are also changes in categories. Manuals have been updated. Conservation Commission can authorize someone to sign on interventions if notify DES within 5 days. Permits may now be mailed in directly to DES.

Other towns seem to contract out for GIS mapping. Unsure if forest society still does it, other firms as well. CNRPC contracts out for GIS mapping as well. To discuss at future meeting for proposal for natural inventory resources.

At end conversation DES said no to aerator, however lot of consideration about other types of alternatives to address the blooms. Both water sheds need a septic survey. DES wants to purse grant that is a loan forgiveness program and once project completed the loan is forgiven, so no tax impact and no cost match. Still needs to be approved at Town Meeting. Still pricing out estimated at no more than \$30,000.

Ross was unable to attend the OHRV meeting since it was rescheduled due to no minute taker. Ross had offered to take the minutes for the originally scheduled meeting since he could not attend the rescheduled meeting. The OHRV Chair denied his offer stating a minute taker had already been scheduled for the new meeting and it would not be fair to the minute taker.
