#### **Roadside Mowing Bid:**

#### **Culvert Liberty Hill:**

Highway Superintendent made a motion to recommend the bid from Hall Excavating to the Board of Selectmen for the Liberty Hill Road culvert construction. Mike Flecchia seconded. All were in favor, approved unanimously.

The Highway superintendent then provided an overview of the bids received and the scope of the project. Robust discussion ensued.

#### Paving Bid:

The Highway Superintendent provided an overview of the bids received and noted that Tia Hooper assisted in the comparison chart that was being presented.

Mike Flecchia made a motion to recommend the bid from Busby Construction based to the Board of Selectmen, based on unit price. Danny Aucoin seconded. All were in favor motion approved unanimously.
