Speakers must be residents of the Town of Henniker, property owners in the town of Henniker, and/or designated representatives of recognized civic organizations or businesses located in the Town of Henniker. When they are at the podium, speakers first need to recite their name and address for the record. Visitors should address their comments to the board and not to any individual member. Each speaker shall be provided a single opportunity for comment, limited to three (3) minutes. Public forum shall be limited to fifteen (15) minutes. Visitors should not expect a response to their comments or questions since the Board may not have discussed or taken a position on a matter. Public Comment is not a two-way dialogue between speaker(s), Selectmen, and/or the Town Administrator. The Chair will preserve strict order and decorum at all Board of Selectmen meetings. Outbursts from the public are not permitted.

JOB DESCRIPTION: The Wastewater Superintendent is a department head and has responsibility for the Wastewater Treatment Plant and collection system in the Town of Henniker.

The Superintendent performs technical work necessary for directing the operation of the wastewater plant and collection system. He/she works directly with, as well as supervises activities of personnel engaged in laboratory, collection system and plant functions.

ACCOUNTABILITY: He/she ensures compliance with all local policies and procedures, as well as State and EPA requirements and permits. The Superintendent enjoys considerable independence under the general direction of the Town Administrator. His/her work is reviewed through conferences, reports and program results.

KNOWLEDGE, SKILLS AND RESPONSIBILITIES: Specific responsibilities assigned to this position include, but are not limited to the following:

- 1. Operates the wastewater treatment plant to meet or exceed the permit standards established by Federal and State regulating agencies.
- 2. Inspects and maintains efficient plant operation. Oversees daily laboratory analysis, which assures compliance with State and EPA requirements. Makes adjustments to treatment plant operations as required.
- 3. Establishes program(s), plan(s) and procedure(s) to ensure efficient operation of the wastewater system.

Background: HB 1221 provides a one-time payment by the state equal to 7.5 percent of the New Hampshire Retirement System (NHRS) employer contribution costs for Group I teachers and Group II police and <u>firefighters</u> in state fiscal year 2023. State payments have been issued to each town as a reimbursement. As required, the town budgeted and paid 100 percent of the NHRS employer costs, and the state issued a reimbursement equaling 7.5 percent of eligible Group I and Group II employer contribution costs. NHMA recommended that municipalities report these funds as revenue on the MS 434 to be recorded as part of the tax rate certification process. 

New Hampshire Retirement System

State Contribution for Teachers, Police and Firefighters. The State of New Hampshire had funded a portion of the normal retirement costs for teachers, police and firefighters, a practice that dated back to 1940 under the predecessor retirement systems. Since 1977, the state contribution had been set by statute at 35% of the cost, with municipalities, counties and school districts paying 65% of the cost for teachers, police, and firefighters. (Municipalities, counties, and schools paid 100% of the cost for all other employees enrolled in the NHRS.)

The state contribution rate was lowered to 30% in 2010, to 25% in 2011, to \$3.5 million in 2012 and then eliminated in 2013. **This resulted in local governments paying 100% of the retirement costs for teachers, police, and firefighters in 2013 and beyond.** <u>Chart H</u> illustrates the local government employer contribution rates for every \$100 of compensation from 2002 through 2023. The significant increases in the rates from 2010 to 2015 are primarily the result of elimination of the state contribution, reductions in the assumed rate of return, and investment losses from the 2008- 2009 recession.



On July 1, 2021, employer contribution rates for fiscal years 2022-23 will increase an aggregate 19.6% over the 2020-21 fiscal year biennium. The NHRS Board of Trustees certified these rates on September 8, 2020, and noted the most significant drivers of this rate increase, in order of impact, were: 1) the reduction of the assumed rate of return from 7.25% to 6.75%; 2) the adoption of post-retirement mortality assumptions; and 3) a reduction in the payroll growth factor.

HB 1221 was signed by the Governor on June 17, 2022, and takes effect July 1, 2022 and requires the State of New Hampshire to reimburse 7.5 percent of local employer contributions to the New Hampshire Retirement System (NHRS, the retirement system) made in fiscal year 2022 for Group I teachers and Group II police and fire members.







AGENDA DESCRIPTION: Consideration of a 2023 warrant article to raise and appropriate funds to construct a fire pond on the property identified in the Town of Henniker tax records as Tax Map 1, Lot 549 FX, containing 6.79 acres and further identified as 1105 Old Concord Road, in the Town of Henniker.

LEGAL AUTHORITY: Town Meeting; RSA Chapter RSA 32:3, VI, 32:7, VI and 31:95-b

FINANCIAL DETAILS: Up to \$81,000

BACKGROUND: On December 10, 2020, Selectmen approved an expenditure from the 2020 Fire Department budget of \$6,850.00 for a field survey to put in a fire pond on old Concord Road, to include permitting. KV Partners completed the design, and the Fire Department is prepared to move forward with permitting for the project and present the easement agreement to Granite Holdings of Deering, LLC. The fire pond will be essential to extinguish and prevent the spread of fires to this region of the town which includes timber and fuel businesses.

In June 2022 the Selectboard reaffirmed a decision to authorize an easement agreement for the pond.

We expect to file permits before the end of the month and be ready to begin construction in spring 2023. The estimated cost of construction is \$81,000. Following our procurement policy, we should put the construction project out for sealed bid.

In addition, authority to raise and appropriate funds to construct the fire pond should come from Town Meeting approval of a warrant article. The town may seek offsetting grant and donation revenue.

All work is dependent on easement agreement and NH DES permitting.

The board authorized the Town Administrator to craft the Warrant Article

TOWN ADMINISTRATOR COMMENT: Concurs with Finance Department recommendation:

FINANCE DEPARTMENT COMMENT: Consulted with Finance Department, DRA, and Town Auditor for appropriate language. This is considered a Special Warrant Article 32:3, VI (e) non-lapsing. Funds raised from donations and grants shall be accepted and accounted for according to RSA 31:95-b Appropriation for Funds Made Available During Year.

Unanticipated funds for the project are considered temporarily restricted (i.e.: both purpose and time restricted). The donation to the Fire Pond Project is an example of a temporarily restricted gift. In this case the gift is purpose restricted (fire pond) and time restricted (it may not be expended until the fire pond project commences).

Revenue and expenditures for a capital project are accounted for in specific project fund.





AGENDA DESCRIPTION:	Readoption of the optional and all veterans' tax credit to keep the current adopted veterans tax credits in place in the amount of \$200. Consider modification to tax credit amount up to \$750.

BACKGROUND: The New Hampshire Legislature passed, and Governor Sununu signed into law House Bill 1667 (Chapter 121, Laws of 2022), amending eligibility criteria for certain veterans' property tax credits. Effective on July 26, 2022, the bill amended RSA 72:28, the <u>"Standard and Optional Veterans' Tax Credit</u>," and RSA 72:28-b, the <u>"All Veterans' Tax Credit</u>," to <u>expand the eligibility requirements</u> of the veterans' tax <u>credit to include individuals who have</u> not yet been discharged from service in the armed forces. Under RSA 72:27-a, IV amendments to tax credits and exemptions which require adoption will only apply "in a municipality which previously adopted the provision only after the municipality complies with the procedure" specified in RSA 72:27-a, II, unless otherwise expressly required by law. Nothing in HB 1667 created an exception to this readoption requirement. See attached

Town Administrator Comment:

For Henniker's veterans' tax credits to **remain in place** as they are now (\$200), we <u>must</u> readopt the <u>optional</u> veterans' credit and the <u>all-veterans'</u> credit, or the credits will revert to the standard \$50 Standard required by the State. The optional and all-veteran's credits amounts must be the same.

Town of Henniker granted 124 Optional Veterans' Tax Credits and 5 All Veteran's Credits. Total Veterans' credits of 129 at \$200 = \$25,800 in tax credits. If the town does not readopt, the veterans' credit will revert to the standard \$50. The tax rate impact of the current \$200 credit over the minimum standard credit of \$50 is .03 cents on the tax rate.

The maximum Tax Credit allowed is \$750.00. For comparison to other communities see this link: <u>DRA 2021 Veterans'</u> <u>Exemption and Tax Credits Summary Report</u>

The town may consider increasing the veterans' credit up to \$750. The <u>estimated impact</u> on 2022 tax rate over <u>the</u> <u>current</u> <u>\$200 credit</u> would be on rate and \$300,000 value property: \$300 Credit = +.02 on rate and \$5.35 \$500 Credit = +.05 on rate and \$16.05 \$750 Credit = +.10 on rate and \$29.43 These amounts are estimates as we do not know the 2023 valuation or tax rate. This may require an additional warrant

TECHNICAL INFORMATION RELEASE <u>UPDATED</u> TIR 2022-005 Date: October 24, 2022

A Technical Information Release is designed to provide immediate information regarding tax laws administered by the Department or the policy positions of the Department as a service to taxpayers and practitioners. A Technical Information Release represents the position of the Department on the limited issues discussed herein based on current law and Department interpretation. For the current status of any tax law, practitioners and taxpayers should consult the source documents (i.e., Revised Statutes Annotated, Rules, Case Law, Session Laws, etc.).

Statutory Change to Property Tax Credits for Veterans – Readoption Required

The New Hampshire Legislature passed, and Governor Sununu signed into law House Bill 1667 (Chapter 121, Laws of 2022), amending eligibility criteria for certain veterans' property tax credits. Effective on July 26, 2022, the bill amended RSA 72:28, the "Standard and Optional Veterans' Tax Credit," and RSA 72:28-b, the "All Veterans' Tax Credit," to expand the eligibility requirements of the veterans' tax credit to include individuals who have not yet been discharged from service in the armed forces.

Under RSA 72:27-a, IV amendments to tax credits and exemptions which require adoption will only apply "in a municipality which previously adopted the provision only after the municipality complies with the procedure" specified in RSA 72:27-a, II, unless otherwise expressly required by law. Nothing in HB 1667 created an exception to this readoption requirement.

As a result of the passage of HB 1667, municipalities should consider the following:

- For municipalities with the Standard Veteran's Tax Credit:
 - No readoption is required, the expanded eligibility will apply to the Standard Veterans' Tax Credit for the April 1, 2023 tax year.
 - Municipalities can adopt the Optional Veterans' Tax Credit under RSA 72:28, II and/or the All Veterans' Tax Credit under RSA 72:28-b with the expanded eligibility for the April 1, 2023 tax year.
- For municipalities with an Optional Veterans' Tax Credit under RSA 72:28, II:
 - The existing Optional Veteran's Tax Credit will remain in place for the April 1, 2022 tax year.
 - The Optional Veteran's Tax Credit, at the existing amount or at a new amount, must be *readopted* pursuant to RSA 72:27-a to remain in place and include the expanded eligibility effective for the April 1, 2023 tax year.

- If the Optional Veteran's Tax Credit is not readopted, the Standard Veterans' Tax Credit will be in place for the April 1, 2023 tax year, which will include the expanded eligibility requirements.
- For municipalities with the All Veterans' Tax Credit under RSA 72:28-b:
 - The existing All Veterans' Tax Credit will remain in place for the April 1, 2022 tax year.
 - The All Veterans' Tax Credit, at the existing amount or at a new amount, must be *readopted* pursuant to RSA 72:27-a to remain in place and include the expanded eligibility effective April 1, 2023 tax year.
 - If the All Veterans' Tax Credit is not readopted, the Standard Veterans' Tax Credit will be in place for the April 1, 2023 tax year, which will include the expanded eligibility requirements.

The Department will examine warrant article submissions to ensure that communities which have previously adopted these credits are aware that they must be readopted to remain in effect. Additionally, and in accordance with our usual practice, before approving a municipality's veterans' tax credit totals reported on the "Summary Inventory of Valuation" (MS-1) the Department will determine that a legislative body vote to readopt these credits has occurred.

BACKGROUND:

Last year (2022) the Town appropriated \$58,000 for this purpose. An ADA door was installed for approximately \$5,000; the balance (\$53,000) lapsed. This Warrant Article requests that the lapsing funds be re-appropriated in order to pursue a badly needed solution for accessibility to the Library; it further names the TFL Board as agents to expend the funds.

TOWN ADMINISTRATOR COMMENT: Seek guidance from DRA and Finance Department on wording. Suggest adding and/or repair to replacement and add provide ADA access to the library.

FINANCE DEPARTMENT COMMENT: Unexpended 2022 Library warrant article appropriate will lapse to fund balance. The project could not commence.

BACKGROUND: The Lions Club partnered with NexTrex Plastic Bag and Film Community Recycling Program for the Town of Henniker. Since starting the Transfer Station recycling project in mid-November, we have collected 533 lbs of usable recycling. We are currently collecting between 100-120 lbs a week (more the past couple of weeks with the holidays). That number may continue to go up a bit as more people learn about the program. In addition to keeping the plastic film out of the waste stream and eliminating the need for Trex to produce new plastic, the project will also save the town a few hundred dollars a year since not having the plastic film items in the hopper will reduce the weight of trash we have to pay to have taken away. We estimate that we will collect between 4000 and 6500 lbs a year.

NexTrex donates a bench to the community for every 500lbs of bag and film. Link to Information video

Section 31:95-e

31:95-e Acceptance of Personal Property Donated to Towns and Village Districts. -

I. Any town or village district at an annual meeting may adopt an article authorizing the board of selectmen or board of commissioners to accept gifts of personal property, other than money, which may be offered to the town or village district for any public purpose, and such authorization shall remain in effect until rescinded by a vote of town or village district meeting.

II. Prior to the acceptance of any such gift with a value of \$5,000 or more, the selectmen or board of commissioners shall hold a public hearing on the proposed acceptance. For gifts with a value of less than \$5,000, a public hearing on the proposed acceptance shall be at the discretion of the selectmen or board of commissioners. If no public hearing is held, the board of selectmen or board of commissioners shall post notice of the gift in the agenda and shall include notice in the minutes of the board of selectmen or board of commissioners meeting at which such gift is discussed. The acceptance of gifts under this paragraph shall be made in public session of any regular board of selectmen or board of commissioners meeting.

III. No acceptance of any personal property under the authority of this section shall be deemed to bind the town or village district to raise, appropriate or expend any public funds for the operation, maintenance, repair, or replacement of such personal property. **Source.** 1991, 25:2, eff. Item #2 – Selectwoman Hooper motioned to approve the Consent Agenda Tuesday, December 20th, 2022, seconded by Selectman Flynn. The motion passed, unanimously.

Item #3 – Volunteer Appointments:

Dina Pinnell – Energy Committee Item: discussion motion, second and vote

Selectwoman Hooper moved to reappoint Dina Pinnell to the Energy Committee for a period of 3 years, seconded by Selectman Marko. Selectman Marko notes that Ms. Pinnell is a valued member of that team. Selectman Flynn concours. Motion carries unanimously.

Item #4 – John Cassel and Sandra May 55 River Rd – Request Board of Selectman put forth a 2023 warrant article to discontinue roads bisecting property (592)

John Cassel of 55 River Rd shares that he and his wife, Sandra May, have plans to construct new garage, which will have an apartment and an office. This construction will need a new septic system as well. However, where they intend to build there is an intersection of two class six roads. These roads are mostly impassable past their house. Mr. Cassel was given two options: either to come before the Board have them bring this to the Town during Town Meeting or have 25 residents sign a petition to have to brought to vote during Town Meeting. Mr. Cassel felt that bringing this to the Board was his best option.

The Selectboard discussed the matter, noting that there have been items like this in the past that seemed cut and dry but ended up being more complicated issues than initially anticipated. Town Administrator Kendall shared that Highway Superintendent Leo Aucoin had said he sees no issue with this matter, and that he wasn't sure why these roads had not been discontinued in the past. The Selectboard discussed bringing the idea of discontinuing these roads to a public hearing, with Chairman Blomback noting that he wants the public to have ample opportunity going forward. Fire Chief Jim Morse, member of the OHRV Committee, was present at the meeting and the Selectboard ask for his input regarding ATV trails. Chief Morse noted that he is not the chairman and does not speak for the whole committee, but there is not an ATV trail in the area that Mr. Cassel is discussing. Chief Morse likes the idea of working with Mr. Cassel and Ms. May on getting a trail.

Selectwoman Hooper moved to table the discussion until January 3rd at the time of a public hearing and the appropriate constituents as outlined by Chairman Blomback are contacted and invited to attend, seconded by Selectman Marko. Motion carries unanimously.

CONTINUED BUSINESS:

No continued business.

NEW BUSINESS

Item #5 Police Department encumber request

Police Chief Matthew French begins his request by making it clear that he does not take large purchases lightly. He explains that he is frugal with his own money, and even more frugal with other people's money. Chief French spoke with Hillsboro Ford who anticipate a one year wait on police vehicles. Chief French became concerned that the current vehicles will not last that long and wants to act as soon as possible. Chief French notes that there is excess funds in the 2022 Police budget due to staffing shortage. He is asking to use those funds to purchase two Ford Explorers to be used as police cruisers to replace the 2016 Ford Explorer, with an excess of 125k miles, and the 2011 Ford Expedition. These purchases were listed in the 2023 budget and, pending the Board's approval, will be removed from that budget after this purchase.

The Selectboard discussed specifics of this purchase, noting the \$127,588 price tag (each vehicle coasting \$63,794 for the vehicle and equipment) that came from the State. Chief French shared that this estimate was his worstcase scenario number. Selectman Marko noted that there could be hidden costs associated with the old cruisers with continual maintenance bills. Chairman Blomback confirms with Chief French that the Chief is proposing to purchase these vehicles with the 2022 budget, and that the 2023 budget would decrease by a proportional amount. Chairman Blomback expressed some concern about needing to take this purchase to bid but given the urgency of this purchase the

Selectboard decided to move forward. Selectwoman Hooper makes the motion to waive Selectboard Policy Section III.1 Procurement Policy bid process and authorize Police Chief to issue Purchase Orders to preferred vendors not to exceed \$127,588 for the purchase and fit-up of police vehicles and to encumber \$127,588 2022 police department operating budget to fund the purchase, Selectman Flynn seconds. Motion carries unanimously.

Item #6 Proposed Town – Department Warrant Articles under \$100,000

Fire Department – Construct Fire Pond

Chairman Blomback detailed that this project is planned on being done at Lot 549-FX which is 1105 Old Concord Rd. Fire Chief Jim Morse is asking the Selectboard to put this project on the warrant article. This fire pond will be essential to extinguish and prevent the spread of fires to this region of the town which includes timber and fuel businesses. The cost of this project could be up to \$81,000. Chief Morse notes that we have done the surveying and the initial steps, but we are waiting on the DES to finish this. Selectwoman Hooper notes that there have been other delays due to the DES and asks Chief Morse if he has an idea for a timeframe. He does not.

Selectwoman Hooper notes that seeking donations could be useful in offsetting the cost of this project. Discussion continued around logistics and legal implications of creating such a fund, with concerns expressed about how to return the donations if the permitting for the project is unsuccessful. Chief Morse asks if he can start the DES permitting process to which the Board said yes by consensus.

Selectwoman Hooper moves that the Selectboard direct the Town Administrator to craft the language for the creation of an expendable trust fund for the construction of the fire pond along with crafting the language to raise and appropriate the \$81,000 for this project along with finding out how we need to create this special fund for the donations to offset the funding for this project, Selectman Marko seconds.

Chairman Blomback asks Chief Morse how much he anticipates will be donated. Chief Morse shares that this fire pond will be an asset to the businesses in this area, and there could be significant donations. There was more conversation about the expendable trust fund with members of the Selectboard wanting to make sure the warrant article has clear language about this fund and how it will be used. **Motion carries 4-1.**

Selectwoman Hooper asks Selectman Osgood why he was opposed because he had not spoken on the matter. Selectman Osgood states that he feels it is unnecessary and the Townsfolk have enough to get the departments what they need.

There was some discussion on the easement for this project, which the status of was not certain.

Item #7 Proposed Other Warrant Articles

Readoption of the optional and all veterans' tax credit

Town Administrator Kendall notes that every town in NH is putting this on their warrant this year. This is because the NH legislature passed, and Governor Sununu signed into law HB 1667 (Chapter 121, laws of 2022) which amends eligibility criteria for certain veterans' property tax credits. This became effective on July 26, 2022 and affects both the Standard and Optional Veterans Tax Credit, as well as the All Veterans Tax Credit. If the Town wishes to keep the Veteran's Credit at \$200 then this will need to be readopted.

Selectwoman Hooper asked if this includes Gold Star Families. The Selectboard also discussed the possibility of increasing the Veterans credit. Town Administrator Kendall offered to bring follow up information about both subjects to the January 3rd meeting, and the Selectboard tabled this discussion until then.

Communications

Item #12 – Town Administrator Report: Bob Garside (Building Inspector/Code Enforcement Officer) turned in his resignation. His last day is January 6th. He plans on resolving as many open projects as he can. He doesn't want to leave us high and dry. Town Administrator Kendall recommends the Board establish an hourly rate for the work he does after January 6th. The Selectboard agreed by consensus to authorize the Town Administrator to post the position and come up with an hourly rate.

NH finally made good on their retirement contributions that they owed the town for Police and Fire for a total of \$17,690.39. The Town has received those funds, but because it is unanticipated revenue more than \$10,000 there will need to be a public hearing to accept these funds. Town Administrator Kendall would like to do this at the January 3rd meeting, which seems like it will be a busy meeting.

The Broadband Committee put out a request for information from the internet providers for the Town. They plan on overlaying this data on 911 maps to show gaps in service. On January 4th TDS will be meeting with the Broadband Committee to show what they have to offer.

The communication tower has met a roadblock- we are waiting for an environmental and historical survey to be completed but do not have anyone on the team with the expertise to preform such a survey.

The funds for the Garaventa Lift from the 2022 Warrant Article will lapse. The NH DOL Elevator Inspection Division will not grant approval for the plan as submitted and the library will have to make a new request.

The food pantry is seeing a lot more patrons and are utilizing almost all of their space. They are considering relocating, possibly to the main floor of the Grange. Selectwoman Hooper noted that although there is not usually a report from the food pantry, that it would be helpful to know their numbers and understand better how our community is impacted.

Town Administrator Kendal met with Productions Inc., the company who set up the audio-visual connections at the Community Center. There was discussion on what work they are doing at the Community Center, as well as discussing Productions Inc.'s cost for recording and distributing Town Meeting.

Item #13 - Selectmen Reports:

Selectman Marko reported on a Planning Board meeting where they held a public meeting for the proposed zoning changes. Selectman Flynn reported on the Historic District Commission where they had discussion about lighting at the Historical Society. He also met with Henniker Youth Athletics who were very busy discussing budget and giving reports for the various sports.

Selectwoman Hooper reported on the CIP which continues to have meetings. They will be changing their start time from 6:30 to 5:30. They have some items to revisit and an updated item from transfer station. Hopefully we will have updated information from the rescue squad who are having issues finding numbers on requests.

Chairman Blomback reported on the Concert Committee who discussed transferring money into their operating budget with the intention of paying bands a little more next year.

Selectman Osgood reported on the Broadband Committee who met with TDS and the Conservation Commission is looking at a natural resources update.

Dear Selectmen/Assessing Officials,

The Department of Revenue Administration is charged with the responsibility of annually equalizing the local assessed valuation of municipalities and unincorporated places throughout the state. The Department has conducted a salesassessment ratio study using market sales, which have taken place in Henniker between October 1, 2021 and September 30, 2022. Based on this information, we have determined the average level of assessment for real property in Henniker as of April 1, 2022.

Based on the enclosed survey, we have determined a median ratio for real property in Henniker for Tax Year 2022 to be **100.1%**. The median ratio is the generally preferred measure of central tendency for assessment equity, monitoring appraisal performance, and determining reappraisal priorities, or evaluating the need for reappraisal. The median ratio, therefore, should be the ratio used to modify the market value of properties under review for abatement to adjust them in accordance with the overall ratio of all properties in Henniker.

We have also determined the overall equalization ratio (weighted mean) for real property in Henniker for Tax Year 2022 to be **98.7%**. This ratio will be used to equalize the modified local assessed valuation for all real property and utilities in Henniker.

In an effort to provide municipalities with more detailed information regarding their level of assessment (i.e. equalization ratio) and dispersion (i.e. coefficient of dispersion and price-related differential), we have prepared separate analysis sheets for various property types (stratum). See attached summary sheet showing Henniker's stratified figures and a further explanation of the DRA's stratified analysis.

Please review the list of sales used in determining your assessment-sales ratio. If any incorrect data has been used, or if you would like to meet with us to discuss this ratio or an alternate ratio methodology as outlined in the accompanying information sheet, please contact us immediately.

You will be notified of the total equalized valuation for Henniker when the Department has completed its process of calculating the total equalized valuation.

Dear Mr. Blomback:

The following is notification of a one-time bridge payment being made available to your municipality in State Fiscal Year 2023 based on the passage of Senate Bill (SB) 401 effective July 2022. SB 401 directs the Department to divide and distribute a \$36 million one-time payment between all New Hampshire municipalities that have municipally owned bridges per state definitions. Fifty percent (50%) of the distribution is based on your municipality's percentage of statewide municipal bridge deck surface area and the remaining fifty percent (50%) of the distribution is based on your municipality's percentage of statewide population. This one-time bridge payment is not related at all to the quarterly block grant aid payments that a municipality receives. This payment can only be used on the maintenance, construction, or reconstruction of municipally owned bridges.

This one-time payment is anticipated to be available to the Town of Henniker during the month of December 2022 as follows:

December 2022 Actual Bridge Payment: \$203,706.17
