THIS OFFER IS AVAILABLE FOR A LIMITED TIME ONLY. Due to market conditions, the price is subject to change after 9/25/2020 without notice and is not guaranteed until a signed agreement is executed by both parties.

This contract is to confirm that the <u>Town of Henniker</u> (acct# 6662, 5901) agrees with **Ayer & Goss, Inc.** to purchase **heating oil and propane** to be consumed during the 2020-2021 heating season, which begins on or after September 1, 2020 and ends on May 31, 2021, according to the following contract:

Additional Terms and Information

- Ayer & Goss, Inc. guarantees to deliver the contracted gallons of fuel on our automatic delivery during the heating season. Final deliveries of contracted fuel will be made at the end of the heating season. Any gallons delivered above the contracted volume will be priced at the market price on the day of delivery.
- Automatic deliveries will continue after your contracted gallons are gone, unless you notify our office in writing and instruct us to stop deliveries, in which case your final contracted fixed price delivery must meet our minimum delivery requirements.
- The customer guarantees to take delivery of the fuel purchased at the fixed, non-fluctuating price as stated above and agrees that Ayer & Goss, Inc. will be their sole provider of fuel for this location.
- If less than 90% of the contracted fuel is consumed, we reserve the right to assess a penalty, which will be calculated based on the unused contracted gallons.
- Any credit balances left will be applied to the next year's contract or refunded.
- o The prepay and budget payments are to be used to pay for the agreed contracted gallons of fuel only. Any other charges, such as propane, must be paid for from the invoice. (Monthly statements will not be sent when an account has a credit balance.)
- Customers may track account balances and/or make payments via our website: www.ayerandgoss.com
- o If we are doing an ACH/EFT and payment is denied for any reason, such as incorrect information or lack of funds, any fees assessed by our bank may be passed on to the customer. If an auto EFT payment is denied due to lack of funds in your bank account, the price per gallon may increase by 10 cents for the remainder of the contract.
- Ayer & Goss, Inc. cannot be held responsible for any interruptions in fuel oil or propane supply or changes due to circumstances beyond our control, including incidents or regulations involving the federal government, foreign policy or production; and disasters or acts of God which may limit the supply of fuel temporarily or permanently.
- The customer agrees to ensure safe access to their oil fills and propane tanks, cleared of ice, snow or other obstructions. Please remember that our delivery trucks are about two feet wider than a passenger car and much taller. If we are unable to safely access your tanks to make a delivery, we will not be responsible for an interruption in service or for any damages or related problems due to an out of fuel situation.
- O Ayer & Goss, Inc. will not be held responsible for normal maintenance that must be done to customer's driveway and/or property as the result of deliveries made by our vehicles.
